## **7. PRESENTATION/DISCUSSION/PUBLIC HEARING –**

7.1 James Peters Sutter County Office of Education: Presentation from James Peters was made to the Board of Education with regards to the various projects that he is associated with at ENHS. Packet of information was referenced during presentation labeled Item # 7.1. Mr. Peters stated that there is a current MOU with the County Office of education that allows him to work with the school districts. A discussion took place with regards to the cost of Mr. Peters coming to help out at ENHS with the various projects. At this time there is no CAP limit in the MOU. Further discussion took place with regards to how much it costs for Mr. Peters department to help out with the various projects. Questions were asked of who oversees and inspects the work done by Mr. Peters and his department. The Presentation continued with Mr. Peters going over the various different projects such as the AG Classroom ramp and the Shop Upgrade. With regards to the AG Ramp would be to rebuild the ramp and then put in the sidewalk path to travel through the DSA. With regards to the shop upgrade he went over the different layout/diagram for the project. Went over the fact that some of the things can be done and installed by students and the teacher. Mr. Peters stated that we need to go through the procurement process. Board moves forward as a maintenance project with a contractor that is bonded. Next step would be looking at getting stream pathways money spent.
